1. **OWNERSHIP AND COMPOSITIONS:** Licensor warrants and represents that it is the owner of a valid Canadian copyright for the above noted musical composition (hereinafter referred to as the “Composition”) and has the right to grant the license herein provided.

2. **LICENSE:** Licensor grants to Licensee the non-exclusive right, privilege and license to use the Composition in the manufacture and sale of sound-recordings in all forms, whether now or hereafter devised or discovered (“Records”) throughout the world (“Territory”), for the album entitled below.

3. **ROYALTY:** For such records made and distributed, the royalty shall be 0.091 (CND) for each recording, and in the event of future recordings, the royalty shall be the statutory rate in effect at the time the record is released. All royalties and fees shall be paid in entirety to: **Signpost Music**.

4. **ACCOUNTING:** It is understood that payment is to be made in advance for the above stated number of recordings. In the event additional recordings are produced:

- a) Licensee shall either pay in advance for more copies or render to Licensor semi-annual statements, and payments thereof, of all royalties payable hereunder, within 45 days after June 30 and December 31, for each period for which any such royalties accrue pursuant to the terms hereof. Licensee shall account and pay for all royalties due to Licensor accruing from the date when copies are produced for release beyond the number of copies referred to above.

- b) Licensor shall have the annual right, on thirty (30) days written notice at Licensor's expense, to audit Licensee's books and records with respect to royalties payable in accordance to this agreement.
- c) Upon Licensee's failure to account to Licensor and pay royalties as herein provided, Licensor may give Licensee written notice, by Certified Mail, that, unless the default is remedied within thirty (30) days from the date of the notice, the license will automatically terminate. Such termination shall render either the making or the distribution, or both, of all records for which royalties have not been paid, actionable as acts of infringement under the United States and Canadian Copyright Acts.
- d) This License applies only to sound recordings and their packaging. Separate arrangements must be made for the production and distribution of sheet music or other printed forms.

5. **CREDIT:** In regard to all records manufactured, distributed and/or sold hereunder, Licensee shall include in the label copy of all such records, or on the permanent containers of all such records, printed writer/publisher credit in the form of the name of the writer and the publisher of the copyrighted work as listed below:

6. **WARRANTY & INDEMNITY:** Licensor indemnifies and holds harmless Licensee, its successors and assigns from any and all loss, damage, cost or expense, including attorney fees, by reason of any adverse claims by others in and to the subject matter hereof, or by reason of any breach of any of the expressed warranties herein contained, or by reason of an adjudication invalidating said mechanical rights or copyright privileges under which this license is granted.

7. **ASSIGNMENT:** This agreement is assignable by either party and shall be binding upon the heirs, legal representatives, successors and assigns of the parties hereto.

9. **TERM:** This license shall continue in effect for the life of the copyright on the Composition.
